

CARIBBEAN EQUESTRIAN ASSOCIATION DRESSAGE CHALLENGE Saturday, November 7th, 2020 National Equestrian Centre, Vesey Street, Devonshire, Bermuda

Judge: Heather Stalker (USA)

Please note that some of the Rules have been modified for 2020 and are formulated and based on the Covid-19 restrictions in effect in the participating countries. It is understood that some countries have very tight restrictions and other countries are more relaxed. Each country will be responsible for the own Covid-19 regulations. The amendments are highlighted in red.

The Competition will be held from **October to November 2020** in accordance with, for the FEI Tests, the FEI Rules for Dressage Events, 25th edition, effective 1st January 2015 (please consult <u>www.fei.org</u> > Dressage > Rules) and FEI General Regulations, Pony Regulations and Veterinary Regulations currently in force. And for the USEF Tests the USEF Rules for Dressage 2015 (<u>www.usef.org</u>). Tests are USEF Tests 2019, with most recent updates where applicable. <u>https://www.usdf.org/downloads/forms/2019.asp</u>

With the following exceptions:

The Tests must be carried out entirely from memory and all movements must follow in the order laid down in the Tests.

Horses may be entered more than once in the same dressage class, subject to the CEA Dressage rules in Article 2.

ARTICLE 1 - PRINCIPLES

1.1 The event consists of:

a) - The CEA Mini Dressage Challenge/Team and Individual Competition

- USEF Training 3
- USEF First 3
- USEF Second 3
- USEF Third 3
- USEF Fourth 1
- FEI PSG
- FEI Intermediate 1 and 2
- FEI Intermediate A and B
- FEI GP & SP Special
- Freestyles offered for all above levels with a qualifying score of 58%

There will be no qualifying score needed for the rider/horse combination to enter Freestyle tests.

b) - Additional Classes – Tests that are not part of the CEA Dressage Challenge may only be held after the completion of the CEA Dressage Challenge.

FORMULA

1.2 This Formula is flexible depending on the number of Days available in each country Day 1: Judges' arrival.
Day 2: Challenge Competition Classes followed by the additional Classes
Day 3: Optional clinic to be arranged between each country and the judge as needed

*The Competition/Clinic may also be held on travel days or the same day if absolutely necessary but only in the above order of; competition then clinic.

As there will be no physical judge on the grounds, the above Formula is not needed.

ARTICLE 2 – PARTICIPATION

This competition is open to all CEA affiliated National Federations. It is open to all Adult competitors 17 Years & Over from the 1st of January of the year of the competition and it is open to all Children competitors - 16 Years and Under who may compete, from the 1st of January of the year of the competition.

2.1 Horse (Or Pony) / Rider Combinations: That has competed in either/both of the CEA DC/FEI WDC at a Senior level of FEI Advanced and above cannot compete at a lower level of below FEI Advanced/Third Level and be a member of their host country's team.

2.2 That has competed in either/both of the CEA Dressage Challenge/FEI WDC at any level and received 57% or more may not compete at a lower level than which the 57% or more was received and be a member of the TEAM.

2.3 Notwithstanding Article 2.1 and 2.2, a rider that has competed at PSG or above and wishes to compete in this competition at FEI Medium level/Second Level and below may only do so, on a green or medium level horse and may also be eligible for team selection.

2.4 Should a horse (or pony) /rider combination re-enter the competition after more than 1 annual absence (missed 1 year) of both the CEA DC and/or FEI WDC competitions, they will be permitted to participate at the level deemed suitable by the country NF's Organizing Committee. Such combinations will not be eligible for the Team Competition until they have been re-classified (i.e. competing at a particular level so that scores can be assessed whether they are below or above the 57 %.) It is the responsibility of the National Federation to select participants (horse/riders) for this competition. NF's are free to set qualification limits and may also hold selection trials in the case of too many riders.

2.5 **The Adult Competition** is open to the following age group from the 1st January of the year in which they reach their 17th birthday:

- USEF Training 3
- USEF First 3
- USEF Second 3
- USEF Third 3
- USEF Fourth 1
- FEI PSG
- FEI Intermediate 1 and 2
- FEI Intermediate A and B
- FEI GP & GP Special
- Freestyles offered for all above levels with a qualifying score of 58%

Amended for 2020: No qualifying scores for Freestyle tests are required.

2.6 **The Children's Competition** is open to the following age group from the 1St January of the year of which they reach their 16th birthday and under:

- USEF Training 3
- USEF First 3
- USEF Second 3
- USEF Third 3
- USEF Fourth 1
- Freestyles offered for all above levels with a qualifying score of 58%

Amended for 2020: No qualifying scores for Freestyle tests are required.

TEAM COMPETITION: For 2020: there will be FOUR team results:

ADULT TEAM ADULT FREESTYLE TEAM CHILDREN TEAM CHILDREN FREESTYLE TEAM

Note: Adult and Children Team Members will be Horse's first time in the ring and Rider's first time in the ring.

Freestyle Team Eligibility: Once a rider and horse combination have completed their CEA Dressage Challenge Test, they are eligible for the Freestyle Team.

2.7 The Competition is open to competitors domiciled abroad. 'Competitor Living Abroad' (Ref. Art 123.10 of the FEI GR) – A competitor is considered to be living abroad if he spends more than six months of a year in a foreign country (in this case, the host country). These riders may be members of their host country's team.

2.8 The Challenge Competition is open to all horses and ponies of any origin. From this point forth, both horses and ponies will be referred to as 'horses' where applicable.

2.9 The CEA Dressage Challenge competition must take precedence over any other competition organized in its framework but, if necessary, horses entered may take part in additional classes of the national competition organized in the framework of the Challenge, as per the rules.

2.10 It is the responsibility of the National Federation to select the participants (horses/riders) for this Competition in strict accordance with the participation rules above and make sure that riders and horses comply with these rules. NF's are free to set qualification limits or hold selection trials consistent with the principals of the CEA Rules.

- 2.11 A rider is allowed to start any number of times in the Competition, but can enter no more than:
 - A. With the same horse twice but in two different classes within two consecutive levels (e.g.: First and Second Level).
 - B. In the same class but with no more than with two different horses.
- 2.12 A horse may go twice:

- A. With one rider in 2 consecutive classes
- B. With 2 riders in 2 separate classes, also consecutive
- C. A Horse may start more than twice at lower levels only (Training & First

Levels) A horse is allowed to start no more than twice in the competition (consistent

with article 2.12)

The horses first time in the ring only can be part of the team The riders first time in the ring only can be part of the team

2.13 NFs have the choice to either enter all riders into one class or to divide them among all levels including the additional classes. NF's are completely free in their choice.

ARTICLE 3 – CLINIC

The Clinic is not compulsory. Each NF is free to organize an educational event on Day 2 to suit their specific needs within limits and providing that the Judge is willing to tutor. However, the DC must be dually informed so that proper arrangements may be made with the Judge. The DC will inform all NF's of any fees relating to the Judge. **THERE ARE NO CLINICS FOR 2020**

ARTICLE 4 - GROUND JURY

Since the FEI Judges are not able to travel nor can they judge a show virtually, the CEA Dressage Committee has appointed Heather Stalker (USDF/USED 'R' Judge) to judge the virtual shows in the participating countries.

4.1 The cost for judging, scribe, and scoring is US\$20 per test (CEA and Freestyle). The videographer is to be placed at 'C' in an elevated Jury Box. The bell official may sit either to the left or right of the videographer but must maintain the correct social distance.

4.2 The same Judge is to be used by all participating countries.

4.3 The judge and her scribe will also score the tests. The Secretary of each Federation is to ensure the correct documents are emailed to the Judge before the start of the competition of each country. The Judge will also sign all of the relevant documents which will then be sent electronically to the respective Secretary of each Federation.

ARTICLE 5 - DRESS & SADDLERY

5.1 Dress and Saddlery shall follow FEI or USEF rules, as applicable to, the test being ridden

5.2 NFs shall have the option to waive jackets in advance of the competition due to weather, without needing the permission of the judge.

Amended for 2020: Since there is no live Judge on the show grounds, the Organizing Committee is to assign a knowledgeable official or steward to visually inspect dress and saddlery.

ARTICLE 6- THE CLASSIFICATION

6.1 Separate ranking lists (one for each level in the 17 years and above age group and one for each level in the 16 years and under age group) will be established and will count towards the final classification.

6.2 **The Individual Classification i**n each country of the Zone is decided as follows:

The winner is the competitor having the highest total points converted into percentage, the second the one with the next highest total and so on. The Individual Freestyle classification will follow the exact rules as the Individual classification. With a Champion awarded for each Level.

In case of equality of points for the first, second and/or third places **in a country**, the higher collective marks will be decisive for the placing. If a further tie exists, the higher collective marks for the

rider (No 4. Rider's position and seat. See test sheet) will be decisive. In case of equality of points for places other than the first three, the competitors concerned are given the same rank.

In case of equality of points for the first, second and/or third places in the entire Competition, the higher collective marks will decide for the placing. If a further tie exists, the higher collective marks for the rider (No 4: Rider's position and seat. See test sheet) will be decisive.

There will be no additional percentage system applicable for the Individual Classification.

6.3 The Team Classification in each country is calculated as follows:

The Team results will be the 3 best scores in the Adult competition and the 3 best scores in the Children's competition. **The first test of the horse and rider** must be the one counted for the TEAM. It is of no importance whether all team members participate in the same level or whether they compete in different levels. The team members' ultimate results, expressed in percentages, will be added to determine the Team Classification.

6.4 The Team Freestyle classification will commence in 2020.

In case of equality of points for the first, second and/or third places in the Team Competition, the team whose third placed rider achieved the higher percentage will be placed first.

A percentage system will be applicable for the Team scores only for the purpose of the Team Classification as follows:

Add .5 % to scores at First Level Ass 1 % to scores at Second Level Add 1.5 % to scores at Third Level Add 2 % to scores at Fourth Level Add 3 % to scores at PSG Level Add 3.5 % to scores at Intermediate I Level Add 4 % to scores at Intermediate II, A & B Level Add 5 % to scores at Grand Prix Level

ARTICLE 7 - THE PRIZES

7.1 The OC within each NF is responsible for the distribution of prizes in the normal way (at least one prize for each four competitors).

ARTICLE 8 - THE ORGANISING COMMITTEE

8.1 As per article 4.3, NFs/OCs are requested to e-mail to the CEA Secretary jacherry@northrock.bm

full printed results within 3 days of the competition to all countries participating in the competition.

ARTICLE 9 – MISCELLANEOUS

9.1 **Climate:** In exceptional weather conditions and with the authority of the Ground Jury, the Competition may be held indoors if the competition arena has the proper measurements. The decision to move indoors must be taken at least 24 hours before the beginning of the competition in order to give the OC enough time to set the arena properly.

9.2 **Horses Schooling**: On no account and under penalty of elimination, may any horse take part in the Competition which has been schooled by anyone other than the competitor, mounted in the saddle, in or outside the town where the Competition is held, from 18.00 hours on the day preceding the Competition until the Competition is finished.

9.3 **Copy Rights:** any rider entered by his or her NF in the CEA Dressage Challenge concedes the rights of any photographs of the rider and/or horse and accepts their publication on any website, magazine or newspaper.

9.4 The CEA Dressage Challenge must be organized strictly according to CEA Rules.

9.5 The CEA Dressage Committee is entitled to make reasonable amendments to the present rules. Any omissions or variations of interpretations as it relates to these rules will be concluded by the Dressage Committee and the CEA and their final ruling stands.

FEI CODE OF CONDUCT

1. In all equestrian sports the horse must be considered paramount.

2. The well-being of the horse shall take precedence over the demands of all interested parties and commercial concerns.

3. All handling and veterinary treatment must ensure the health and welfare of the horse.

4. The highest standards of nutrition, health, sanitation and safety shall be encouraged and maintained at all times

5. During transportation, adequate provision must be made for ventilation, feeding, watering and maintaining a healthy environment during transportation.

6. Emphasis should be placed on increasing education and training and equestrian practices and on promoting scientific studies in equine health.

7. In the interests of the horse, the fitness and competence of the rider shall be regarded as essential.

8. All riding and training methods should take account of the horse as a living creature and must not include any technique considered by the F.E.I. to be abusive.

9. National Federations must establish adequate controls in order that all persons and bodies under their jurisdiction respect the welfare of the horse.

10. The National and International Rules and Regulations in equestrian sport regarding the health and welfare of the horse must be adhered to, not only during National and International events, but also during training: such rules shall be regularly reviewed.

ENTRY FEE: \$35.00 per class – must be members of the BEF and the BDG.

CLOSE OF ENTRIES: Friday 23rd October, 2020. Entries to be delivered to Hinson Hall only. Late entries will not be accepted.
