CLOSE OF ENTRIES: Wednesday, November 11, 2020 by 6pm

Entries <u>MUST</u> be emailed to Karen Amos at kamosbef@gmail.com (take a picture with your phone if you don't have a scanner). Emails will be time stamped in case COVID restrictions require that we limit entries or NEC Entry Passes. Hard copy entries and payments may be delivered to Breakaway, Inwood Stables or Hinson Hall. Payments by cash or cheque made payable to the Bermuda Equestrian Federation. No online payments.

HORSE SHOW COVID POLICY

The BEF COVID Policy MUST be adhered to. Entry to the NEC will be limited to 75 people and allowed only to those with an entry pass. Entry passes can be shared if contact information for each used is provided to the Show Committee. Entry Passes will be allocated as follows

- a. Horse show officials and (pre-Arranged) volunteers
- b. Riders (plus an adult for junior riders)
- c. Coaches (with a rider competing)
- d. Grooms (one pass per horse entered)
- e. At close of entries, extra entry passes will be allocated by the Show Committee.

All entry passes will be recorded with contact information for attendee tracing if necessary.

Masks must be worn in the collecting ring and main ring (if not mounted on a horse) and whenever social distancing of at least six (6) feet cannot be maintained.

Only seven (7) riders are allowed in any ring at a time with one (1) groom/coach/supporter each. Only entered riders with one (1) coach/groom/supporter each are allowed in the course walk.

Entry passes and rider packs will be available for pick up on Thursday night, 5:30-7:30, at the course build at NEC. Rider packs will include schedules, entry passes, and any show updates.

Please respect the rules of COVID safety for yourself and your community. We have been given the opportunity to horse show again in Bermuda so let's keep this privilege!

RULES

- When entering this show, all horses and ponies must be registered with, and competitors must be members of, the BEF prior to the close of entries.
- Correct money for each class must accompany entry form.
- The organizing committee reserves the right to change, cancel or combine classes or to deny inappropriate entries, if they have reason to do so.

- Competitors should be neatly and suitably attired in coat, hunt cap with harness. Refer to BEF Rule Book for further details on dress.
- Any cruelty or abuse, whether it is physical, verbal or otherwise, directed at any horse, person, or
 official of the show, will result in immediate elimination by the show committee. Refer to BEF

- Fences in the warm-up ring must be jumped in the direction indicated by the red & white flags.
- No person shall have any contact, direct or indirect, with any part of the fences in the main ring or the warm-up ring, while a horse or pony is jumping. Rapping a horse will result in elimination. No false ground lines may be used.
- Any situation or condition not covered by the rules of the BEF will be decided by the Show Director.
- Withdrawal of entries refer to BEF Rule Book. Any subsequent requests for changes must be directed to the Show Secretary.
- Jumping classes will be held under FEI Rules. Seven minutes will be allowed for competitors to walk each jumping course.

ENTRIES

- Enter the correct horse/pony registration number on the entry form where required as well as the BEF membership number of the rider. The age and date of birth of a junior competitor is also required. Entry forms without this information may not be accepted.
- Post entries will be accepted prior to the start of a class as provided in the current BEF Rules
- The age of a junior competitor will be taken as of September 1, 2020. A junior competitor shall be 18 years or under.

ENTRY FEES: \$25 per class

POST ENTRIES: \$35

ADMINISTRATION FEE: \$25 for each horse/pony entered in the show

SCHOOLING: No schooling will be offered

SCHEDULE FOR BEF SUPPORT SHOW – 21 November 2020

UPDATED 6 November 2020: new classes, revised article numbers, revised order of schedule

New class. CLASS A - PUDDLE JUMPERS - Height of fences not to exceed 0.70m.

Open to horses and ponies. USEF Table IV Section 1. The round is decided by adding together the faults incurred over the course and any penalties for exceeding the Time Allowed. In the case of equality of faults, ties will be broken on the following basis: an "Optimum Time" (defined as 4 seconds less than the Time Allowed for the course) will be posted on the course plan; the horse with the time on course closet to this Optimum Time (over or under) will prevail in the tie, next closest next, etc.

CLASS 3 – #PN1 PONY JUMPING - Height of fences not to exceed 0.75m.

FEI Article 238.2.1. Athletes with equality of Penalties for any place are placed in accordance with the time taken to complete the round. In the event of equality of Penalties and time for first place, there

may be a jump-off over a shortened course over obstacles, not to be increased in height and/or spread.

CLASS 4 – #PN1 PONY JUMPING – Height of fences not to exceed 0.85m.

Revised article number. FEI Article 238.2.2. This is a Competition against the clock, but in the event of equality of Penalties for first place, there will be one jump-off against the clock. Other Athletes are placed according to their Penalties and time in the first round.

New class. CLASS B – HORSE JUMPING – Height of fences not to exceed 0.85cm.

USEF Table IV Section 1. The round is decided by adding together the faults incurred over the course and any penalties for exceeding the Time Allowed. In the case of equality of faults, ties will be broken on the following basis: an "Optimum Time" (defined as 4 seconds less than the Time Allowed for the course) will be posted on the course plan; the horse with the time on course closet to this Optimum Time (over or under) will prevail in the tie, next closest next, etc.

CLASS 1 – #H1 HORSE JUMPING – Height of fences not to exceed 0.95cm.

FEI Article 238.2.1. Athletes with equality of Penalties for any place are placed in accordance with the time taken to complete the round. In the event of equality of Penalties and time for first place, there may be a jump-off over a shortened course over obstacles, not to be increased in height and/or spread.

CLASS 2 - #H2 HORSE JUMPING - Height of fences not to exceed 1.0m.

Revised article number. FEI Article 238.2.2. This is a Competition against the clock, but in the event of equality of Penalties for first place, there will be one jump-off against the clock. Other Athletes are placed according to their Penalties and time in the first round.
