BEF SUPPORT SHOW RULES

1. When entering this show, all horses & ponies must be registered with the BEF and competitors must be members of the BEF prior to the close of entries.
2. If not paying online correct money for each class must accompany entry form.
3. **The organizing committee reserves the right to change, cancel or combine classes or to deny inappropriate entries, if they have reason to do so.**
4. Any cruelty or abuse, whether it is physical, verbal or otherwise, directed at any horse, person, or official of the show, will result in immediate elimination by the show committee. Refer to BEF codes of Conduct.
5. Fences in the warm-up ring must be jumped in the direction indicated by the red & white flags.
6. No person shall have any contact, direct or indirect, with any part of the fences in the main ring or the warm-up ring while a horse or pony is jumping. Rapping a horse will result in elimination. No false ground lines may be used.
7. Any situation or condition not covered by the Rules of the BEF will be decided by the Show Directors and the Organizing Committee.
8. All queries should be emailed to jacherry@northrock.bm for consideration and a reply.
9. For withdrawal of entries, refer to the BEF Rule Book. Any subsequent requests for changes must be directed to the Show Secretary.
10. **Jumping classes will be held under FEI Rules.**

PRIZE LIST: Ribbons will be awarded to 6th place.

ENTRIES: Enter the correct horse/pony registration number on the entry form where required as well as the rider's BEF membership. The age and date of birth of a junior competitor is also required. Entry forms without this information may not be accepted.

AGE OF JUNIOR: The Age of a junior competitor will be taken as of September 1st 2022. A junior competitor shall be under 19 years.

ENTRY FEE - \$20.00 per class

ADMINISTRATION FEE: - \$20 Each Horse

FIELD CREW FEE: - \$10 Each Horse

REFUNDS – 50% refund permitted with a Dr. Certificate or a Veterinarian Certificate

BEF MEMBERSHIP: All entries must be paid up members of the BEF and horses need to have been re-registered with the BEF for 2023.

Class 4 - #PN1 Pony Jumping

FEI Article 238.2.1. Height of fences not to exceed 0.75m (2' 5").

Competition against the clock. Competitors with equality of penalties for any place are placed in accordance with the time taken to complete the round. In the event of equality of penalties and time for first place, there may be a jump-off over a shortened course over obstacles, which may be increased in height and/or spread.

Class 5 - #PN2 Pony Jumping

FEI Article 238.2.1. Height of fences not to exceed 0.85m (2' 9").

To be judged as for Class 4.

Class 10 – Clear Round Horse Jumping Additional Class

Height of fences not to exceed 0.85m (2'9")

Class 6 - #H1 Horse Jumping

FEI Article 238.2.1. Height of fences not to exceed 0.95m (3' 1").

To be judged as for Class 4.

Class 7 - #H2 Horse Jumping

FEI Article 238.2.1. Height of fences not to exceed 1.00m (3' 3").

To be judged as for Class 4

Class 8- #H3 Horse Jumping

FEI Article 238.2.1. Height of fences not to exceed 1.10m (3' 7").

To be judged as for Class 4.

Class 9 - #H5 Horse Jumping

FEI Article 238.2.1. Height of fences not to exceed 1.20m (3' 11").

To be judged as for Class 4.
