- 1.4 There will be an individual ranking per Country, per Region and for the World for all 3 Categories.
- 1.5 Placing: Athletes will be placed according to aggregate Penalties over both rounds and the time incurred in the second round of each Competition.
- 1.7 The Category A qualifies for the World Final.
- 2.6 Horse must be six years old or over.
- 3.1 The three categories are open to all athletes from the beginning of the year in which they reach their 14<sup>th</sup> birthday.
- 3.2 A horse may compete with only ONE Athlete, in only ONE Category throughout the FEI world Jumping challenge during the same year.
- 3.4 An athlete may ride in all 3 Categories with 3 different horses. In addition to his/her Individual results, if an athlete competes in more than one Category only the **results of the highest Category** will count for the Team ranking (see Art. 8.4) of the Rules.
- 3.6 Athletes having participated at more than 3 International Jumping events (this includes Senior Regional/Continental Games & Championships/WEG/OG) in competitions at 1.35m and higher are not allowed to compete.
- 3.12 An athlete/horse combination eliminated in one competition of the Category A, B or C may start in the other competitions of the same Category. An athlete/horse combinatin eliminated in the 1st round of any competition, is NOT allowed to start in the 2nd round of the competition
